- # Hunting Dogs must be a current financial member of an approved recognised association. ( evidence must be provided )
- ## Discounted fee is for one dog only, on the production of a Pension Card N.B. additional dogs full fee applicable.

All dogs over the age of six months that are not registered by the due date, (31 August 2018) will be in breach of the Tasmanian State Government's 'Dog Control Act 2000' Failure to comply will result in fines of \$163 for each offence.
